Landscaping with Native Plants

Whether you're a veteran gardener or a beginner, you'll enjoy "Landscaping with Native Plants" presented by expert native plant grower, **Terry Divoky**. Terry will treat us to an inspiring power point program. Then she'll display a collection of native plants from her nursery that are not only well suited to our unique growing conditions, but will enhance wildlife habitat. So, please join your fellow North Fork native plant lovers at 10:00 am until noon on Wednesday, June 16, at Sondreson Hall to learn how to beautify your property with plants that thrive in our tricky gardening environment. Bring a sack lunch if you'd like to stay for an informal native plant identification walk afterward.

Volunteer Weed Wrangler Training

Come on out on Friday, June 18 and help your NFLA Weed Committee by becoming a volunteer "Weed Wrangler". Volunteer training takes place on the 18 from 9:30 a.m. until noon at Sondreson Hall with lunch provided. As part of our recently awarded Resource Advisory Committee (RAC) grant, Tris Hoffman of the Forest Service and Dawn LaFleur of Glacier National Park will be on hand to train volunteers to identify the 14 species of noxious weeds that have invaded the North Fork, and to teach us how to plot weed infestations using a GPS unit. During the "weed season", volunteers will be called upon to help map weeds. As part of the grant, volunteers will be reimbursed for mileage. Join us on June 18 and receive your free "Weed Wrangler" T-Shirt. Bring work gloves, a hat, sunblock, water, and a notebook. You will be provided with a complementary weed identification handbook.

The NFLA's Fire Mitigation Committee will sponsor a workshop on July 7, immediately preceding the Summer Inter Local meeting. The theme of the workshop is "Save Your Home." It will feature presentations on smoke and carbon monoxide alarms, fire extinguishers, dry sprinklers, water tanks and trailers, and the use and abuse of propane. The workshop counts as the North Fork's annual Firewise Day, required to maintain our Firewise Community status. It will begin at 9 a.m. in Sondreson Hall, with time for demonstrations and questions before the Inter Local lunch at noon. NFLA Road Committee

In the fall of 2008; then NFLA president, Molly Shepherd appointed a NFLA committee to look at various issues concerning the North Fork Road. The committee was chaired by Betsy Holycross and included Margaret Heaphy, Steve Weber, Steve Berg and Ed Heger. In August of 2009 after Betsy had been elected president of the NFLA, Margaret Heaphy took over as chairman.

During the course of the past year, the committee has met with and worked with numerous federal, state and local officials regarding the road, to include: Glacier National Park, Flathead National Forest, US Fish and Wildlife Service, Montana Department of Transportation, Montana Fish, Wildlife and Parks, County Commissioner, Public Works Director and County Road Department. Summaries of all these meetings can be found on the NFLA website http://www.nflandowners.com/Road.html. The road committee reported its findings to the NFLA and the North Fork Road Coalition for Health and Safety.

The committee has striven to educate the community on the history of earlier efforts to pave the road and the environmental issues that arose during that process in the early '80's. It also has helped to educate the community as

well as local officials about the possibility of doing a feasibility study on the road. Additionally, Margaret has done extraordinary research on dust abatement and control measures and reported those to the community. She has worked with and liaised with the county and state regarding these issues.

Now, over a year later, at the NFLA president's request, the BOD unanimously agreed to suspend road committee activities and the duties and responsibilities of its members. The email address will be disabled. The summer may be a busy one for road issues but the focus does not belong on the NFLA road committee.

The State and Flathead County sponsored feasibility study is underway and members who want to stay abreast of what's going on and/or comment on the process and issues should visit the study website at http://www.mdt.mt.gov/pubinvolve/northfork/. We will make sure that any updates we receive will be posted on http://www.nflandowners.com/Road.html, however, the most up-to-date information will be available at the State of MT feasibility study website linked above and members are urged to visit it to stay informed.
