Dues may be paid by mail or in person at any NFLA meeting. **Additional contributions are welcome.**

In addition to checking on properties, the North Fork Patrol also pays a reward of up to \$500 for information leading to the arrest and conviction of any wrongdoers on the North Fork. The Patrol is <u>not</u> a law enforcement authority nor is it a full-time security provider; it is a neighborhood service of volunteers helping to keep an eye on their neighbor's properties as best as they can.
