Minutes of August 9, 2020 Meeting

Minutes approved by acclamation.

Treasurer's Report – Chris Heitz (Attachments 1 and 2)

For the month ended August 2020, the NFLA had 370 paid members. There was no income in August and expenses totaled \$1,934.05. The \$891.96 for the computer purchased earlier in the year was transferred from NFLA Whitefish Credit Union account to the operating fund to cover cash flow.

For the fiscal year ended August 31, 2020. NFLA membership was 370 which is exactly what it was on August 31, 2019. Total NFLA funds in reserve is \$15,000 and the yearend report is currently unaudited.

The Treasurer was thanked for her report.

Chris also presented the 2020-2021 budget to NFLA membership. She highlighted the fact that budgeted income includes dues, donations, fund raisers and interest income. Expenses for the next fiscal year are expected to exceed income in part due to increased costs for Welcome Committee, insurance, and road dust abatement. If expenses are not covered by income, they will be covered by NFLA reserve funds. In summary:

Irv Heitz moved to accept the budget as presented, the motion was seconded and approved by acclamation.

Committee Reports

North Fork Patrol – Mark Heaphy

In the event of an emergency, get to the nearest phone and call 911. In the past month, a head-on car crash involving alcohol, trespassing and another break-in were reported. A total of 3 break-ins between July – mid-August were reported this year and two of them are related. With regards to trespassing, if the property is not on the NF Patrol list, call the Sheriff's Office. Mark recommends that talking with neighbors and letting them know when you are gone and who is authorized to be at your property. Flathead County deputies increased summer patrols on the North Fork as a result of grant funding. Those funds have now run out. Bear, wolf and moose season begin September 15. Regular hunting season opens October 24. Bow season is open now.

Firewise Report – Lynn Ogle (Attachment 3)

Lynn provided photos of the smoke / toxic air quality impacting the Pacific Northwest and the North Fork. There are currently 9 fires in Montana which have burned over 1 million acres, in addition to the fires in CA, WA and OR. Air quality will continue to be an issue until significant rain occurs.

Sunshine Committee – Bonny Ogle

Bonny reported 11 cards sent out in August.

Welcome Committee – Karina Pettey for Gerry Stearns (Attachment 4)

Karina reported the Welcome Committee met in August and proposed a mailing to all landowners that would include a letter, redesigned welcome brochure, a copy of the North Fork zoning and the Living with Wildlife brochure. If anyone has a copy of the wildlife brochure, please get it to Karina or Gerry Stearns.

Supply Committee – Bill Walker for Richard Hildner
