## Treasurer's Report - Chris Heitz

- NFLA membership is 361 members.
- Donations/Dues totaled \$60 while expenses totaled \$3,444.06. The wood stove fundraiser balance is now \$9,710.00 as additional donations continue to come in. The NFLA ending fund balance is \$38,548.76. There is currently \$15,000 is in reserve funds any remaining funds (estimated at \$3,700) from the wood stove fundraiser will be added to Improvement Fund after final payment is made on the stove. If you spot a fire or see an illegal campfire, please call it in to Kalispell dispatch at 406-758-5260. If it is not a fire related issue, call 911. Stage II fire restrictions do not prevent target practice or using a propane grill that can be shut off as long as it is in a cleared area of at least 3 feet in diameter. Mark was thanked for his report.

## Firewise Report – Lynn Ogle

Watch for lightning started fires, we had over 100 lightning strikes north of Polebridge today. The rain received over the past week, while extremely helpful is not a season ending rain event. Current forecast shows area temperatures will be back in the 90s by the weekend. We are in Stage 2 fire restrictions. Shutdown equipment in the woods by 1pm and conduct one hour of observation before leaving the area.
