 - v. Mark Heaphy shared that bear spray could be fired from hip, it is designed to be worn on hip.

 - i. Suzanne Hildner shared that if bears are being seen, they have game cameras and scare devices that can be loaned out. Contact Suzan for help in trying to avoid habituating bears.
